Paul Golob addressed Council about the process of the Cosecha Ct II housing development. He expressed his concerns as to why the land owners were not notified of the project. He said he read about the development in the newspaper that it would be H2A housing and as property owners near the project should have been notified. The City Clerk informed Council and the audience that this project was process until Title 14 of the Granger Municipal Code as a level 3 review, the process was followed, however the municipal code states that landowners within 300 ft. of project are to be notified, which was done. SEPA process was followed and public notification was given of the public hearing in the City's paper of record. She suggested that the municipal code could be change to include a larger area of notification. Mr. Golob stated that there needs to be better communication from the City. Mayor Trevino thanked Mr. Golob for voicing his concerns and would take this into consideration.
